## **Documents Required for Visa in general**

- 1. One copy of the visa application form (click <a href="http://evisa.mfa.uz">http://evisa.mfa.uz</a>) completed and signed by the applicant.
- 2. One photograph. Attach recent color passport-sized photographs to your application form.
- 3. Passport (Passport must have at least one blank page to affix the visa and be valid 90 days more than the period of stay in Uzbekistan).
- 4. Passport photocopy.

#### **Important Notes:**

Incomplete visa applications are not accepted. A personal interview with an applicant may be required. In case any person is declined to obtain an entry visa to Uzbekistan, the Consular Section of the Embassy reserves the right to provide no explanation.

## 1. Visa Application Form:

Visa application form must be filled online from <a href="http://evisa.mfa.uz/evisa\_en/">http://evisa.mfa.uz/evisa\_en/</a>. Form should be printed and signed by the applicant. Two copies must be submitted.

#### 2. Passport:

Original Passport with a validity of more than six months with minimum of two blank pages for visa stamp.

## Please note:

- a. Photocopy of all the used pages of the passport are required; and
- b. Attach all your old passports (if any).

## 3. Photo Specification:

Two recent passport size photographs. Photographs should be 35mm X 45mm, on mat finish paper with white background.

## 4. Covering letter:

A covering letter is required from the applicant mentioning his role in the organization, purpose and who will bear the expenses. The letter should be addressed to: Visa Officer, Embassy of Uzbekistan, New Delhi. The Cover letter will be in Plain paper.

## 5. Forwarding letter:

A forwarding letter is required from the legal representative of the company stating his name, designation, passport number, purpose and who will bear the expenses. The letter should be addressed to: The Visa Officer, Embassy of Uzbekistan, New Delhi. It should be written in company letter head.

#### 6. Invitation Letter:

Invitation letter should be issued by the related Uzbekistan organization mentioning the recognition of the visitor and taking responsibility for the visitor with Telex/Fax number. Original copy is recommended, but email version is also acceptable.

## 7. Financials:

Original personal Bank Statement for the last six months till date duly signed and stamped by the bank.

## 8. Occupational Viability:

Two copy of visiting Card and NOC from the organization.

#### 9. Hotel Booking:

Hotel Reservation copy will be required.

#### 10. Ticket:

Detail Ticket Itinerary (booked air ticket).

## **ii. BUSINESS VISA REQUIREMENTS**

## 1. Visa Application Form:

Visa application form must be filled online from <a href="http://evisa.mfa.uz/evisa\_en/">http://evisa.mfa.uz/evisa\_en/</a>. Form should be printed and signed by the applicant. Two copies must be submitted.

#### 2. Passport:

Original Passport with a validity of more than six months with minimum two blank pages for visa stamp.

#### Please note:

- a. Photocopy of all the used pages of the passport are required; and
- b. Attach all your old passports (if any).

## 3. Photo Specification:

Two recent passport size photographs. Photographs should be 35mm\*45mm, on mate finish paper with white background.

## 4. Covering letter:

A covering letter is required from the applicant mentioning his role in the organization, purpose and who will bear the expenses. The letter should be addressed to the Visa Officer, Embassy of Uzbekistan, New Delhi. Cover letter will be in a Plain paper.

## 5. Forwarding letter:

A forwarding letter is required from the legal representative of the company stating his name, designation, passport number, purpose and who will bear the expenses. The letter should be addressed to: The Visa Officer, Embassy of Uzbekistan, New Delhi. It should be written in company letter head.

#### 6. Invitation Letter:

Invitation letter should be issued by the related Uzbekistan organization mentioning the recognition of the visitor and taking responsibility for the visitor with the Telex/Fax number. The Original copy is recommended, but email version is also acceptable.

#### 7. Financials:

Original personal Bank Statement for the last six months till date duly signed and stamped by the bank.

#### 8. Occupational Viability:

Two copies of visiting/official identity Card.

## 9. Hotel Booking:

Hotel Reservation copy will be required.

## 10. Ticket:

Detail Ticket Itinerary (booked air ticket).

## Visa Fees:

Consular fees should be paid to the following bank details under the name (name specified in passport) of applicants. Payments under different names than applicants wouldn't be accepted.

| 30 days                   | \$ 40 + actual charge \$ 15  |

| up to 15 days             | \$ 50 + actual charge \$ 15  |

| up to 6 months            | \$ 120 + actual charge \$ 15 |
| up to 1 year              | \$ 160 + actual charge \$ 15 |

## **MULTIPLE ENTRY VISA FEE (EXCEPT USA CITIZENS):**

| up to 1 month  | \$ 60 + actual charge \$ 15 (applicable to one month multiple entry tourist visa) |

| up to 1 year   | \$ 250 + actual charge \$ 15  |

## **GROUP VISAS \ FOR TOURIST GROUPS OF 10 PERSONS OR MORE:**

up to 15 days \$ 15 per person + actual charge \$ 15 per group

up to 30 days \$ 25 per person + actual charge \$ 15 per group

Please Note: Tourist group must be minimum 5 adult persons except children.

## **TRANSIT VISAS FEES:**

**up to 72 hours** \$ 40 + actual charge \$ 15

for double entry \$50 + actual charge \$15

Please Note for all type of visas: If visa apply will be on urgent bases visa fee will be for 50% more.
