- Visitor's visa will be issued to the following categories:
  - Visits to family or friends and also for tourism purposes
  - Business purposes
  - Spouse to join a spouse who is in South Africa on a work or study permit
  - Children to join parents who are in South Africa on work or study permits
  - Fiancée/ fiancé to join his or her partner with the intention of marrying within
    90 days
  - Study purposes (max stay 3-months)
  - Research
  - Conferences
  - To work in the production of a movie or show (i.e. in the entertainment industry)
  - For medical purposes (max stay 3-months)
  - Sport events

- Application form-11 (DHA-84) must be signed by the applicant and signature should match the signature on the passport.
- Proof of funds (Last 03 month's bank statement signed and stamped by the bank with a balance of South African Currency R 3000 or equivalent in INR for Delhi and Mumbai.

- Invitation/confirmation for/of medical appointment from private medical institution/practitioner (medical treatment not allowed at public/government medical facilities). The letter must include physical/street address, as well as contact details of the Medical facility/Doctor and name designation and signature; and Host ID copy attested by commissioner of OATHS (South Africa).

- All applications for 11:2 work visa must be accompanied by applicant's CV and notarized copies of qualification certificates in lieu of the requirements for qualification and skills.
- **Note:** The person who signs the invitation letter i.e. HR or Company Executive needs to provide a Valid attested Photo ID (latest 3months) copy by Commissioner of oaths.

  - Relevant professional body, board or council recognized by SAQA in terms of section 13(1)(i) of the National Qualifications Framework Act, where applicable.

- The contribution to the national interest of the Republic.
- A foreigner who invests or has invested in an existing business shall, in addition, submit:
