The type of visa	The required documents
31- Diverse visas	<ul style="list-style-type: none">▪ A filled visa application that is handed out by the interested party (Lebanese or foreigner) residing legally in Lebanon (with the exception of the 3rd and 4th category) or by a touristic institution, or an enterprise (industrial, commercial, civil...), a legal person, or a club.▪ A certified copy of the ID card, the passport and the residency permit owned by the concerned citizen.<ul style="list-style-type: none">• If the interested party is an enterprise, a legal person, or a club, he has to hand out all the legal documents requested (commercial register, investment permit, etc.)▪ A certified copy of the passport that's valid for 6 months at least.<ul style="list-style-type: none">• If the refugee doesn't live in his country of origin, or doesn't own a foreign travelling document, he has to have in hand a resident permit for 6 months at least.▪ A residency permit and a plane ticket▪ A private insurance▪ A document that underlines the profession of the interested party▪ An ID photo▪ A guarantee certified by a competent notary▪ The new version is available at embassies, the application has to be filled out, and an id photo has to be attached to the latter

32 – Touristic group	NB : Available in regional departments via touristic institutions for groups having 8 members at the most
33- Individual touristic visit	<ul style="list-style-type: none"> ▪ A hotel reservation that underlines the date of entry, and exit, the addressee of residency and the title deeds or leases ▪ A plane ticket ▪ A statement of account, a credit card, an attestation of profession, and salary
34- Student visa	<ul style="list-style-type: none"> ▪ An admission statement of a university or an institution that's accredited in Lebanon, or a student card. ▪ A document that proves he has sufficient funds to finance his studies
35- visit for medical purposes	<ul style="list-style-type: none"> ▪ A medical report ▪ A document that underlines the appointment for a checkup at the hospital or by a doctor ▪ A document that proves he has sufficient funds
36- show up at the embassy	<ul style="list-style-type: none"> ▪ A document that underlines an appointment at the embassy ▪ A hotel reservation or an address of residency
37- Transit	<ul style="list-style-type: none"> ▪ A visa or a residency permit if the country where he comes from is not his country of origin
38- work visa	<ul style="list-style-type: none"> ▪ A document that underlines the length of his stay, the reason and the address related to his visit ▪ A document that underlines the commercial relationship in play ▪ A document that underlines his solvency
39- family visit	<ul style="list-style-type: none"> ▪ All the documents requested in 31 ▪ A document that shows the family tie (marriage certificate, birth certificate, extract of family civil register)
39 bis – A visit for an engagement	<ul style="list-style-type: none"> ▪ All the documents requested in 31 ▪ A document proves there is an engagement
Work visa	<ul style="list-style-type: none"> ▪ Terms and conditions are specific in this case

1. Business:

Required documents

- 1) Application form & Checklist form completely filled and signed by the applicant (All information must be correct, accurate, and legible) .
- 2) Letter of intent by the applicant about themselves, stating their job, reason for visiting Lebanon, any other relevant information.
- 3) Undertaking from the applicant in case applying through agent.
- 4) Photocopy of the Passport of the applicant with the validity of minimum 6 months at the time of submission of the application.
- 5) Two identical color photographs, which must be: - of the size of 3.5 cm x 4.5 cm - taken within the last 6 months - taken in front of a plain white or off-white background
- 6) Prior Air ticket booking, to Lebanon, for arrival and departure.
- 7) Hotel reservation in the name of the applicant.
- 8) Invitation Letter from the Business/Company with clear address details in Lebanon mentioning the invited person's name, proposed stay and the purpose of invitation.
- 9) Registration certificate of the company (in Lebanon).

Note:

1. The Embassy has the right not to issue a visa without stating any reason.
2. The Embassy has the right to reject an incomplete or damaged application form; or an application with incomplete or unclear or illegible documents.
3. The Embassy has the right to request (an) additional document(s) other than the documents stated in this form.
4. The Embassy shall not issue visas to applicants who provide untrue information or fake documents, and shall blacklist those who do so.

2. Tourist visa:

Required documents

- 1) Application form & Checklist form completely filled and signed by the applicant (All information must be correct, accurate, and legible.)
- 2) Letter of intent by the applicant about themselves, stating their job, reason for visiting Lebanon, any other relevant information.
- 3) Undertaking from the applicant in case applying through agent.
- 4) Photocopy of the Passport of the applicant with the validity of minimum 6 months at the time of submission of the application.
- 5) Two identical color photographs, which must be: - of the size of 3.5 cm x 4.5 cm - taken within the last 6 months - taken in front of a plain white or off-white background
- 6) Prior Air ticket booking, to Lebanon, for arrival and departure.
- 7) Hotel reservation in the name of the applicant or "Invitation Letter" from the Lebanese counterpart with clear address details in Lebanon. In case the invitee is a Lebanese Citizen, a copy of his/her ID proof must be attached. If the Invitee is foreign national residing in Lebanon, Residential Permit Card with a minimum validity of 3 months should be attached.
- 8) Latest "Bank Statement" of at least 3 months showing a sufficient financial record to bear the expenditures of stay in Lebanon.

Note:

1. The Embassy has the right not to issue a visa without stating any reason.
2. The Embassy has the right to reject an incomplete or damaged application form; or an application with incomplete or unclear or illegible documents.
3. The Embassy has the right to request (an) additional document(s) other than the documents stated in this form.
4. The Embassy shall not issue visas to applicants who provide untrue information or fake documents, and shall blacklist those who do so.

3. Domestic Workers' Visa:

Requirements:

1. A previous authorization delivered by the ministry of labor:

- A certified copy of the foreigner's passport
- A certified copy of the identity card held by the interested party
- A bank guarantee of 1 500 000 L.B.P

2. A visa requested at a GS bureau:

- The authorization delivered by the general security
- A copy of the passport held by the foreigner
- A copy of the identity card held by the interested party
- A guarantee to the general security done via a notary
- An attestation that underlines the profession of the interested party: a salary attestation for instance

3. A labor permit delivered by the ministry of labor:

- A copy of the passport held by the foreigner as well as a copy of his visa
- A copy of the identity card held by the interested party
- An insurance for foreigners via an insurance company
- Medical laboratory tests to which the foreigner is submitted
- A work contract done and signed by the interested party via a notary

4. Granting a residency permit:

- A copy of the passport held by the foreigner as well as a copy of his visa
- The work permit as well as a copy of the latter (valid for 6 months at least)
- A certified copy of the work contract (with the exception of a foreign employer, or the representative of a foreign enterprise, or press correspondents of an agency that has no branches in Lebanon)
- A copy of the identity card held by the interested party
- An extract of family civil registry as well as a copy of the latter
- An extract of family civil registry of the guarantor, as well as a copy of the latter (it must be emitted 3 years ago at the most) - 3 ID photos
- The fees related to the residency permit: 300 000 L.B.P for women and 400 000 L.B.P for men
- A work attestation delivered by the interested party

5. Renewing the residency permit:

- The previous residency permit (original document)
The foreigner's passport as well as a copy of the latter (it has to be valid for a year at least)

- A certified copy of the work contract (with the exception of a foreign employer, or the representative of a foreign enterprise, or press correspondents of an agency that has no branches in Lebanon)
- A work permit (renewed) valid for 6 months at least, as well as a copy of the latter.
- An extract of civil status held by the guarantor (as well as a copy of the latter)
- An extract of family civil registry as well as a copy of the latter
- A copy of the ID card related to the concerned party
- An ID photo of the worker (3 copies)
- The fees related to the residency permit: 300 000 L.B.P for women and 400 000 L.B.P for men
