Jordan issues Electronic Visa popularly known as e-visa for various categories of visa for Bangladeshi nationals willing to travel for a short-term visit. Jordan e-visa is issued as a conditional authorization granted by the central Immigration authority to a foreigner to enter the territory, remain within, or to leave the territory before the validity of the authorization expires.

Jordan e-visa allows an applicant to apply online with scanned copies of very few documents, get the visa processed within a very short time and get the visa online in the form of PDF/Doc file over email. Though Jordan e-visa is a valid visa permit, it doesn't guarantee the right to enter the territory Jordan. The immigration authority reserves the right to grant the final permission of entry.

Requirements:

Visit Visa (One month, three months multiple entries, six months multiple entries)

- A copy of what proves the relationship of kinship reasons for the visit.
- A copy of the residency permit if he/she resides in a country for a period of not less than six months without being a national of that country
- A copy of the existing visa and return ticket if he/she resides in a country without being a national of that country

- Copy of passport or valid travel document for a period not less than 6 months.

Transit (72 hours from entry not extendible)

- A copy of proof that the applicant has access to enter the country in which he/she intend to enter
- A copy of the residency permit if he/she resides in a country for a period of not less than six months without being a national of that country
- Copy of passport or valid travel document for a period not less than 6 months.

Work visa:

- Copy of passport or valid travel document for a period not less than 6 months.
- Copy of the letter of labour recruitment from the Ministry of Labour

Medical Visa: (One month, three months multiple entries, six months multiple entries, 72 hours from entry not extendible)

- A detailed medical report of the medical condition and an appointment in which the hospital in which the hospital or center to be treated in Arabic
- A copy of the annual residency in the country of origin.
- Copy of passport or valid travel document for a period not less than 6 months.

Exit/Entry visa (single entry, three months multiple entries, six months multiple entries)

- A copy of the residency permit if he/she resides in a country for a period of not less than six months without being a national of that country
- Copy of passport or valid travel document for a period not less than 6 months.
- Copy of what proves the reasons for granting a return visa

- Duly filled application form & attach one photograph with white background. To download Visa Application Form, **Please Click Here**
- Invitation letter form the Jordanian counterpart. It is highly recommended to get the Immigration Approval with Invitation Letter from Jordan; otherwise it will delay the process.
- Forwarding Letter from the employer (the company in which the applicant is employed).
- Recommendation letter from professions body such as the Chamber of Commerce, or from the ministry of Commerce.
- An original bank statement for six months (personal account).
- Valid Passport (valid for at least six months).
- Photo copy of your passport page containing the personal details and the address.
- Return Air Tickets and hotel booking
